# **General Update - August 2025**

#### 1. Taxi Activity in Hurlingham Manor

Over the past few months, HMNA has noted a concerning increase in taxis operating within Hurlingham Manor. These vehicles are:

- Not using designated and approved routes
- Frequently displaying dangerous driving behaviour

After receiving reports from residents (including dates, times, images, and vehicle details), HMNA followed up with our Ward Councillor. The matter will be addressed **through JMPD** and the Ward Councillor, not directly with taxi associations.

# **Actions in progress:**

- 1. JMPD, coordinated through Raymond at Savika, will increase their presence from Monday.
- 2. The Ward Councillor will escalate concerns to the Gauteng MEC for Transport.
- 3. HMNA will continue recording and collating details of offending vehicles for official reporting.

- 14% Move to a single unified provider
- 21% Change guarding only at booms

## **Pinotage Gate Closure**

- 63% Support permanent closure
- HMNA is in discussions with Bordeaux North, which is implementing road closures and booms.
  Updates will follow.

**Note:** The poll results are an indication of community sentiment and will be considered alongside broader security, legal, and operational factors. HMNA will determine the most effective way forward and will keep residents informed. Thank you to all who participated.

#### 5. Hurlingham Manor North Status

- HMNA is not a private estate.
- We have two legal booms (Woodlands and Pinotage) renewed every 3 years.
- Roads are owned and maintained by the Johannesburg Roads Agency (JRA).
- Purchasing the roads to become an estate would cost ~R60 million.
- We must comply with all laws and cannot restrict public access beyond current permissions
